Admission Conditions	<p>It is determined by SSPC according to legislation of the Higher Education Authority. Banking and Insurance Program can be applied by all students with YGS section 6 score.</p>
Passing to upper level	<p>The students who graduates from program can pass the following license (4 years) programs, DGS (Vertical Jump Test) or they can continue Anadolu University without an examination. Graduation conditions	<p>Students graduate from the program successfully by completing 120 ECTS / ECTS credits, courses given to him and his internship.</p>
Measurement and Evaluation Methods	<p>Students are subjected to a midterm and final exam each semester. Also, if necessary, they are subjected to projects, seminars, field surveys, quizzes, homework, laboratory, and similar studies in the semester.</p> <p>One course, a midterm examination is given each semester. Mid-term exam, final exam grades and semester studies are given over 100 points. Contribution is 40% of midterm and a letter grade. The final exam and make-up exam is 60% contribution to a letter grade. Final exam is mandatory to take at least 50 points out of 100. Students who don't have score at least 50 point or don't have final test are subjected to make-up exam. Point that is total 40 % of midterm and 60 % final exam to pass course must be 50 and over.</p>
